If you are a UK taxpayer, please also fill in the Gift Aid declaration in order for us to claim back tax paid at the basic rate.

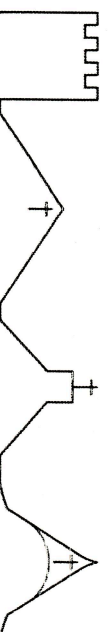
Please note that Gift Aid declarations apply to an individual giver. If a husband and wife both want to give in this way, they must complete and sign separate forms.

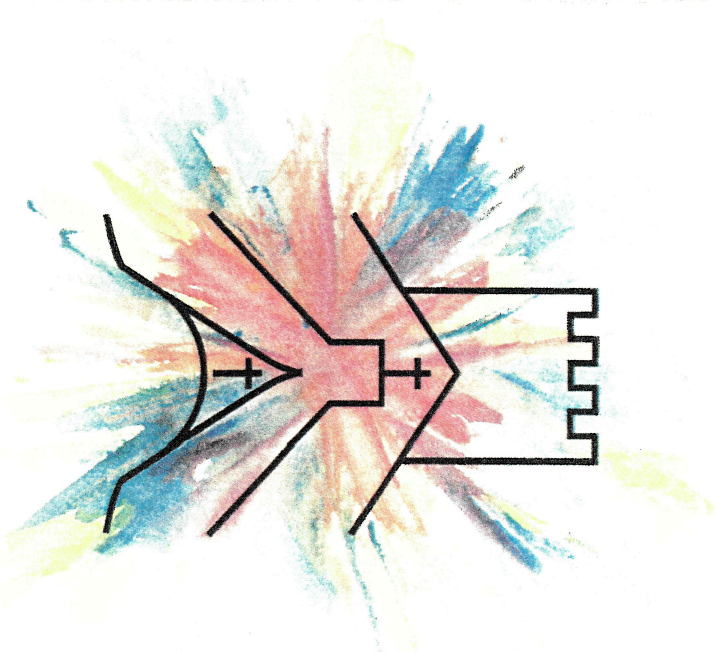
